



## Fixed Price Veterinary Fee Package 2010 Season

### Fresh and Chilled Semen

For mares resident at **Great Brockhamhurst Stud** a fixed price package per cycle is available. This includes:

- Pre-breeding examination and evaluation.
- Communication with stallion owner or semen agent regarding semen shipment.
- Prostaglandin to induce oestrus.
- Any swabs and smears deemed necessary at the pre-breeding examination.
- Unlimited examinations using ultrasound to identify the optimum time for insemination.
- The visits to the stud required to perform the examinations.
- The use of chorulon to induce ovulation.
- Insemination.
- Evaluation of the semen supplied.
- Examination after insemination to check for ovulation and post inseminating problems.
- The first 14 and 16 day pregnancy scans.
- Squeezing twins and follow up exam.
- Caslicks procedure to improve vulval seal.

The package does not include:

- Any biopsies deemed necessary at the pre-breeding examination.
- Sedation if deemed necessary for the safety of personnel and the mare.
- Further ultrasound pregnancy scans.
- Any treatment (oxytocin, intrauterine antibiotics or saline lavage) required to treat uterine inflammation pre or post inseminating.
- Treatment of any condition not associated directly with breeding of the mare or foal at foot.

**The Fee is £260 + Vat for the first cycle and if the mare does not become pregnant subsequent cycles will be charged at £210 + Vat.**

All efforts are made to contact owners to obtain approval of non stud medicine related treatment, however should an emergency arise necessitating treatment of the mare or foal at foot then this will be done after consultation with the stud owner/manager. The practice reserves the right to perform procedures or treatment deemed necessary to ensure animal welfare.
